Treasurer's Report

Annual General Meeting,

September 2022

Dear Members,

I am happy to report that the Hope Valley Netball association continues this year to be in a very sound financial position with a profit for the end of Financial Year (30 June 2022) of \$20,296.76. The accounts have been audited and the auditor's reports is attached along with a detailed profit and loss report, Trial balance and Balance sheet.

We currently have \$63,207.48 sitting in term deposit accounts which are due to mature in November 2022. We also have 24,500.39 in our savings account and \$29,258.56 in the business account. An overall total \$116,930.43 in the bank.

We had a very successful fundraising effort this year. This was a huge effort and largely contributed to the profit this year.

income of \$23,951.00 less costs of \$4,957.21 **Total \$18,993.79** raised through fundraising.

We also received sponsorships totaling \$6,807.92 an outstanding effort by the sponsorship committee.

The only large item of expenditure were the umpire's payments totally \$32,382.22 for the financial year. The uniform purchases \$9,262.55 are offset by uniform sales \$5,510.00 giving a net expense \$3,752.55. This expense was mainly due to gifting uniforms such as t-shirt, jackets, jumpers and polo tops to new and current coaches this year as a thank you for their time and effort.

Due to covid presentation and other costs were down compared to prior years and spending was not required as events and gatherings were limited.

Going into the next financial year, we are in a very good financial position.
